

Privacy Policy (Edited on October 1st , 2019)

1 - Introduction

Your privacy is important to us. This privacy policy has been compiled to better serve those who are concerned with how their 'Personally Identifiable Information' (PII) is being used online. PII, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context.
